In the event of any violation/infringement of the above said conditions and / or the provisions of Anna University Act / Statutes / Regulations, AICTE Act, norms & standards / regulations / guidelines or any other law time being in force, suitable action including suspension / withdrawal of affiliation of course(s) may be initiated against the college.

The provisional affiliation is granted without prejudice to the right of the University of requiring production of certificate required under section 37-B of Tamil Nadu Land Reforms (LC) Act 1961 subject to the decision of the Hon'ble High Court of Madras in W.A.No.3454/2002 batch and W.A.No.3482/2002 batch.

Further, you are requested to submit the Compliance Report for violation of admissions made if any as enclosed in the Annexure within 15 days from the receipt of this letter.

The Management should submit a duly signed undertaking on a Rs.20/ non-judicial stamp paper to the Registrar, Anna University, Coimbatore 641 047, within 15 days from the date of receipt of this letter to the effect that the conditions specified above will be fulfilled.

**Note :** If at any point of time during an inspection or surprise inspection it is found that the norms and standards prescribed are not maintained by the college the provisional affiliation granted above will be withdrawn without any notice.
